LOCATION

Rectory Farm is located within the Leicestershire village of Marston Trussell. Providing recently refurbished office accommodation in a delightful rural setting. The property is located on the south side of the A4304 leading from Lutterworth to Market Harborough, approximately 3 miles from Market Harborough town centre, allowing for easy access to the A14, M1 and M6. The offices are accessed on a shared private road leading off Farndon Road on the south side of the village.

The Property is elected to tax and therefore VAT is applicable to the rent.


LEGAL COSTS
