LOCATION

Astley Grange is situated on the edge of the picturesque village of East Langton, just 3.4 miles from Kibworth and 4.1 miles from the centre of Market Harborough which provides a wealth of local services and a rail connection to Kings Cross St Pancras in under an hour. The Property is also well connected by road, being just 1.4 miles from the A6 and 7.5 miles for the A47.

DESCRIPTION

The Property is located on Astley Grange Farm which is an established commercial estate with ample parking provisions. Unit 14 comprises a warehouse/workshop space, with a level working platform, and roller shutter door.

The Property is a steel portal frame industrial unit with brick and blockwork elevations. It benefits for a three phase power supply, box ceiling lights, providing a ideal workspace for a variety of trade occupiers. The maximum eaves height is 4m, and the roller shutter door dimensions are as follows. (Width: 4.45m x Height: 3.5m)

ACCOMMODATION

The Property has been measured on a Gross Internal Area (GIA) basis in accordance with the RICS Code of Measuring Practice.

The GIA is 2,536 Sq Ft (235.59 Sq M).

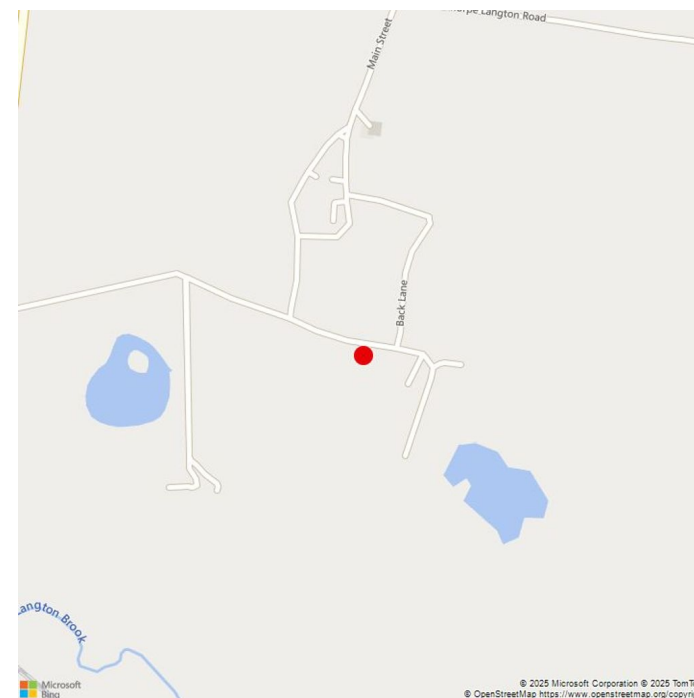
